NOTICE TO PLAYERS

Play is governed by the United States Golf Association (USGA) Rules of Golf and its Decisions, 2019 Legends Junior Tour Local Rules and Conditions of Competition ('Hard Card') and where applicable, the following Local Rules. All local rules listed on Brownwood Country Club scorecards, posted on notice boards or posted on the course are **not** in effect for this tournament. Unless otherwise noted, penalty for breach of a Local Rule or Condition is two strokes.

1. **TEES:** Boys 15-18 Division and Boys 14 & Under Division will play from the **BLUE** LJT tee markers. Girls division will play from the **RED** LJT tee markers.
2. **FORMAT:** The competition is scheduled for 36 holes of stroke-play competition.
3. **CADDIES:** Rule 10.3a is modified in this way: A player must not have a caddie during the round.
4. **AUTOMOTIVE TRANSPORTATION:** Players must walk at all times during play of any hole, and must not use or accept automotive transportation unless acting under the direction of an LJT Referee. Push/Pull carts are permitted. Players may accept rides in a golf cart in between play of #9 & #10.
5. **SCORING:** Scores will be verified at the designated LJT scoring area next to the clubhouse
6. **PROCEDURE FOR TIES:** In the event of a tie for the overall champion, a sudden death hole-by-hole playoff will be conducted, until a winner is declared. The playoff will occur immediately after all scores have been verified. All other ties for awards and LJT Player of the Year points will be split.

SUPPLEMENTAL RULES OF PLAY

1. **Out of Bounds:** In addition to the items listed on the Legends Junior Tour Hard Card, Out of Bounds is defined by:
 - a) The inside edge (golf course side) of all paved roadways.
 - b) The inside edge of Split-rail fencing to the right and behind No. 1 green.
 - c) The inside edge at ground level of posts with woven metal rope to the right of No. 2, 3, 4, 5 and 15.
 - d) The white line to the right of No. 18.
2. **Drop Zone for Hole No. 5:** As an additional option under Rule 17.1, under a penalty of one stroke, a player may drop a ball in the drop zone provided for any ball hit into the red penalty area behind No. 5 green.
Drop Zone Location: Behind No. 5 green.
3. **Cart Path – Gravel Runoff:** Areas of gravel runoff to the side and at the ends of cart paths are considered to be a part of the cart path and relief without penalty will be afforded in accordance with Rule 16.1.
4. **Snack Shack:** For play of all holes, the snack shack found to the left of holes 14 & 16 is an obstruction from which line of play relief will NOT be afforded.
5. **Flower Beds:** Flower beds completely enclosed by an obstruction are ground under repair. MANDATORY free relief will be afforded in accordance with Rule 16.1.
6. **Rock Wall/Railroad Ties – Holes No. 16 & 18:** The rock wall and railroad ties on the right side of No. 16 fairway and No. 18 fairway is an integral part of the course and not an obstruction.
7. **Practice Area:** The chipping green to the right of No. 8 is deemed a wrong putting green with relief MANDATORY under Rule 13.1f.
8. **Doubt as to procedure (Rule 20.1c3):** If a competitor is doubtful of his rights or the correct procedure during the play of a hole, and a referee is not available, players are encouraged to play a second ball in accordance with Rule 20.1c3. The player MUST report the facts to a Rules Committee member as soon as possible or be *disqualified*.
9. **Pace of Play:** The established Pace of Play for Brownwood Country Club is 4:23 for 18 holes. The time to complete each hole is printed on the scorecard. Please see the reverse side of scorecard for LJT Pace of Play Guidelines.
