## NOTICE TO PLAYERS

Play is governed by the 2019 Rules of Golf as approved by the United States Golf Association and R&A, its Interpretations and clarifications, 2020 Legends Junior Tour Local Rules and Terms of the Competition ('Hard Card') and where applicable, the following Local Rules. All Local Rules listed on The Golf Club at Texas A&M scorecards, notice boards or posted on the course are **NOT** in effect for this event. Unless otherwise noted, penalty for breach of a Local Rule is the general penalty.

1. **FORMAT:** The competition is scheduled for 36 holes of stroke-play competition.
2. **CADDIES:** Rule 10.3a is modified in this way: A player must not have a caddie during the round.
3. **TEES:** The Boys 15-18 division will play from the **BLUE LJT** tee markers. The Boys 14 & Under division will play from the **WHITE LJT** tee markers. The Girls 12-18 division will play from the **RED LJT** tee markers.
4. **AUTOMOTIVE TRANSPORTATION:** Players must walk at all times during play of any hole, and must not use or accept automotive transportation unless acting under the direction of an LJT Referee. Push/Pull carts are permitted.
5. **SCORING:** Players will attest scores in the LJT scoring area behind the clubhouse immediately following their round.
6. **PROCEDURE FOR TIES:** In the event of a tie for the overall champion, a sudden death hole-by-hole playoff will be conducted, until a winner is declared. The playoff will occur immediately after all scores have been verified. All other ties for awards and LJT Player of the Year points will be split.

## SUPPLEMENTAL RULES OF PLAY

1. **Out of Bounds:** In addition to the items listed on the 2020 Legends Junior Tour Hard Card, Out of Bounds is defined by:
  - a) Inside edge/curbing of paved roadways and parking lots
  - b) Inside edge of White Posts surrounding driving range
  - c) Black cast-iron fencing
  - d) Wooden fencing to the right of No. 1 and No. 2
2. **In-Course Out of Bounds:** The out of bounds stakes to the right of hole #17 define the out of bounds margin for play of hole #17 only and are deemed to be obstructions during play of all other holes.
3. **Integral Part of the Course:** Stone walls and columns surrounding the property of the golf course are deemed an integral part of the course from which relief will not be granted.
4. **Ground Under Repair:** The following areas are deemed to be ground under repair on the golf course from which relief without penalty is allowed under Rule 16.1.
  - a) All areas encircled with a white line on hole No. 18 (16.1b)
  - b) All areas in bunkers where the liner is coming up (16.1c {Relief must be in Bunker})
  - c) All Flower beds and ornamental plantings located through the green (16.1b)
  - d) All rock/stone beds located through the green (16.1b)
5. **Designated Practice Areas:** The practice putting green behind No. 9 green is deemed a wrong putting green in which relief is MANDATORY for all players. The green is split from No. 9 by two yellow dots.
6. **Model Local Rule D-7 Is In Effect:** Exception 2 to Rule 11.1b applies, except that when a ball played from the *putting green* accidentally hits:
  - a. The player,
  - b. The club used by the player to make the stroke or
  - c. An animal defined as a loose impediment.

**The stroke counts and the ball must be played as it lies.**

7. **Doubt as to Procedure:** If a competitor is in doubt as to a procedure under the rules and a referee is not proximately available, to avoid delay he/she may play a second ball under Rule 20.1c (3). The player **must** report the facts to the Committee before returning his scorecard, otherwise he/she is subject to **disqualification**.
8. **Pace of Play:** The established Pace of Play for The Golf Club at Texas A&M is 4:25 for 18 holes. The time to complete each hole is printed on the scorecard. Please see the reverse side of scorecard for LJT Pace of Play Guidelines.
