NOTICE TO PLAYERS



Play is governed by the 2019 Rules of Golf as approved by the R&A and USGA, its Interpretations and Clarifications, and Legends Junior Tour Local Rules and Conditions of Competition ('Hard Card') and where applicable, the following Local Rules. All local rules listed on Oakmont Country Club's scorecards, posted on notice boards or posted on the course are **not** in effect for this tournament. Unless otherwise noted, penalty for breach of a Local Rule or Condition is two strokes.

1. **Tees:** Boys 15-18 Division will play from the BLUE LJT tee markers. Boys 14 & Under Division will play from the WHITE LJT tee markers. Girls 12-18 Division will play from the RED LJT tee markers.
2. **Automotive Transportation:** Players must walk at all times during play of a hole. Players may accept cart rides in-between the play of any two holes. Non-motorized/push carts will be permitted.
3. **Caddies:** Rule 10.3a is modified in this way: A player must not have a caddie during the round.
4. **Format:** The competition is scheduled for 36 holes of stroke-play.
5. **Procedure for Ties:** In the event of a tie for the championship, a sudden death hole-by-hole playoff will be conducted immediately after all scores have been verified. All other ties for tournament awards will be decided by a scorecard playoff.

SUPPLEMENTAL RULES OF PLAY

1. **Out of Bounds:** In addition to the items listed on the 2021 LJT Hard Card, Out of Bounds is the inside edge/curbing (golf course side) of:
 - Paved roadways
 - White Stakes
 - White dots on tunnel walkway

Note 1: White Stakes left of holes #3, #4, & #13 DO NOT signify out of bounds.

Note 2: A ball coming to rest on or beyond a paved roadway is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.
2. **Drop Zone, Hole 17:** If it is known or virtually certain that a ball that has not been found is in the penalty area on #17, the player may proceed under the applicable options under Rule 17; or as an additional option, drop a ball under penalty of one stroke in the designated dropping zone, which is at about 60 yards.

Note 3: There is no drop zone on hole #4, please disregard club markings on the hole.
3. **Permanent Elevated Power Lines:** If it is known or virtually certain that a player's ball hit a permanent elevated power line or cable during the play of a hole, the stroke does not count. The player must play a ball without penalty from where the previous stroke was made in accordance with rule 14.6.
4. **Integral Objects:** Any object listed on the LJT Hard Card, as well as all retaining walls & stone pillars under or next to property fences are deemed to be integral objects. Free relief is not available.
5. **Ground Under Repair:** The following areas are deemed to be Ground Under Repair; Relief under rule 16.1 is **mandatory**:
 - Area left of #4 Green
 - Area between #3 fairway and #4 green
6. **Obstructions:** The following are deemed to be obstructions for which relief is available without penalty under Rule 16.1:
 - All flower beds and ornamental plantings that are completely encircled or close to an obstruction
 - Stones adjacent to paths
 - Concrete drainage ditches that are not marked as a Red Penalty area are to be treated as an obstruction.
 - Electrical Boxes
 - All on course restrooms / water stations.
7. **Doubt as to Procedure:** If a competitor is in doubt as to a procedure under the rules and a referee is not proximately available, to avoid delay he may play a second ball under Rule 20.1c(3). The competitor **must** report the facts to the Committee before returning his/her scorecard, otherwise he/she is subject to **disqualification**.
8. **Pace of Play:** The established Pace of Play for Oakmont Country Club is 4:28 for 18 holes.
