NOTICE TO PLAYERS

Play is governed by the 2019 Rules of Golf as approved by the United States Golf Association and R&A, its Interpretations and clarifications, 2021 Legends Junior Tour Local Rules and Terms of the Competition ('Hard Card') and where applicable, the following Local Rules. All Local Rules listed on The Rawls Course scorecards, notice boards or posted on the course are **NOT** in effect for this event. Unless otherwise noted, penalty for breach of a Local Rule is the general penalty.

1. **Tees:** Boys 15-18 Division will play from the **BLUE** LJT tee markers. Boys 14 & Under division will play from the **WHITE** LJT tee markers. Girls 12-18 Division will play from the **RED** LJT Tee Markers.
2. **Automotive Transportation:** Players must walk at all times during play of any hole, and must not use or accept automotive transportation unless acting under the direction of an LJT Referee. Push/Pull carts are permitted. Players may accept rides in a golf cart in between play of any two holes.
3. **Procedure for Tie:** In the event of a tie for each Division Champion, a sudden death hole-by-hole playoff will be conducted, until a winner is declared. The playoff will occur immediately after all scores have been verified. All other ties for awards and LJT Player of the Year points will be split.
4. **Scoring:** Scores must be attested and returned immediately after completing your round to the designated scoring area near the clubhouse.

SUPPLEMENTAL RULES OF PLAY

1. **Out of Bounds:** In addition to the items listed on the Legends Junior Tour Hard Card, Out of Bounds is defined by:
 - a) Inside points, at ground level, of white stakes and fence posts
2. **Bricks Adjacent to Cart Paths:** Bricks located adjacent to cart paths are deemed to be part of the same obstruction. Relief without penalty is available under Rule 16.1.
3. **Practice Areas:** The practice green left of #15 green and #18 fairway are designated practice areas on the golf course. The practice green is deemed a Wrong Putting Green with mandatory relief under Rule 13.1f. The bunker adjacent to the practice green is deemed Ground Under Repair in the General Area with relief without penalty available under Rule 13.1f.
4. **Abnormal Course Condition:** The following areas are deemed abnormal course conditions with free relief available under Rule 16.1.
 - Freshly sodded areas on putting greens that interfere with lie, stance, swing or line of play. Line of play relief is only available if the player's ball rests on the putting green.
 - Exposed liners in bunkers that are attached and interfere with lie, stance or swing. Relief area must stay within the bunker.
5. **Doubt as to Procedure:** A player who is uncertain about the right procedure while playing a hole may complete the hole with two balls without penalty under Rule 20.1c(3). The player must decide to play two balls before making a stroke and choose which ball will count if the Rules allow the procedure used for that ball. The player **MUST** report the facts to the committee before returning the scorecard or is subject to disqualification.
6. **Pace of Play:** The established Pace of Play for The Rawls Course is 4:38 for 18 holes. The time to complete each hole is printed on the scorecard. Please see the reverse side of scorecard for LJT Pace of Play Guidelines.
