

# LJT North Texas Classic

Tangle Ridge Golf Course | Grand Prairie, TX

September 11-12, 2021



## NOTICE TO PLAYERS

Play is governed by the 2019 Rules of Golf as approved by the United States Golf Association and R&A, its Interpretations and clarifications, 2021 Legends Junior Tour Local Rules and Terms of the Competition ('Hard Card') and where applicable, the following Local Rules. All Local Rules listed on Tangle Ridge Golf Course scorecards, notice boards or posted on the course are **NOT** in effect for this event. Unless otherwise noted, penalty for breach of a Local Rule is the general penalty.

1. **FORMAT:** The competition is scheduled for 36 holes of stroke-play competition.
2. **CADDIES:** Rule 10.3a is modified in this way: A player must not have a caddie during the round.
3. **TEES:** The Boys 15-18 division will play from the **BLUE LJT** tee markers. The Boys 14 & Under division will play from the **WHITE LJT** tee markers. The Girls 12-18 division will play from the **RED LJT** tee markers.
4. **AUTOMOTIVE TRANSPORTATION:** Players must walk at all times during play of any hole, and must not use or accept automotive transportation unless acting under the direction of an LJT Referee. Push/Pull carts are permitted. Players may accept rides in a golf cart in between play of any two holes.
5. **SCORING:** Scores will be verified at the designated LJT scoring area behind the 9<sup>th</sup> & 18<sup>th</sup> green.
6. **PROCEDURE FOR TIES:** In the event of a tie for the overall champion, a sudden death hole-by-hole playoff will be conducted, until a winner is declared. The playoff will occur immediately after all scores have been verified. All other ties for tournament awards will be decided by a scorecard playoff.

## SUPPLEMENTAL RULES OF PLAY

1. **OUT OF BOUNDS:** In addition to the items listed on the Legends Junior Tour Hard Card, Out of Bounds is defined by:
  - a. Inside edge/cubing of Paved roadways and parking lots
  - b. Inside edge of Property Fencing
  - c. Wooden Posts with connecting cable (Right of No. 3, left of No. 8 green and behind No. 9 tee)
  - d. Barbed Wire fence to the right of No. 5 and No. 13

*Note: A ball coming to rest on or beyond a road is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.*
2. **WRONG GREEN:** The practice green located behind No. 9 green is a wrong green even when not in use and relief must be taken under Rule 13.1f.
3. **IMMOVABLE OBSTRUCTIONS:** The split-rail fencing between No. 5 and No. 13 is deemed to be an immovable obstruction from which relief without penalty is available under Rule 16.1.
4. **STONES ADJACENT TO CART PATH:** Stones and gravel adjacent to cart paths are deemed to be part of the same obstruction. Relief without penalty is available under Rule 16.1.
5. **ABNORMAL COURSE CONDITION:** The following areas are deemed to be Abnormal Course Conditions from which relief is available under Rule 16.1.
  - a. Flower Beds and ornamental plantings
  - b. All areas with a white circle
  - c. Areas of damage caused by a non-burrowing animal
6. **DOUBT AS TO PROCEDURE:** A player who is uncertain about the right procedure while playing a hole may complete the hole with two balls without penalty under Rule 20.1c(3). The player must decide to play two balls before making a stroke and choose which ball will count if the Rules allow the procedure used for that ball. The player **MUST** report the facts to the committee before returning the scorecard or is subject to disqualification.
7. **PACE OF PLAY:** The established Pace of Play for Tangle Ridge Golf Course is 4 hours and 31 minutes for 18 holes. The time to complete each hole is printed on the scorecard and the LJT Pace of Play Guidelines are listed on the reverse side of the scorecard.
