NOTICE TO PLAYERS

Play is governed by the 2019 Rules of Golf as approved by the United States Golf Association and R&A, its Interpretations and clarifications, 2021 Legends Junior Tour Local Rules and Terms of the Competition ('Hard Card') and where applicable, the following Local Rules. All Local Rules listed on Willow Brook Country Club scorecards, notice boards or posted on the course are **NOT** in effect for this event. Unless otherwise noted, penalty for breach of a Local Rule is the general penalty.

FORMAT:

- a. Saturday Four-Ball Matches: A match in which two players play their better ball against the better ball of two other players.
 - b. Saturday Foursomes Matches: A match in which two players play against two other players, and each side plays one ball. The partners shall play alternately from the teeing grounds and alternately during the play of the hole. Penalty strokes do not affect the order of play.
 - c. Sunday Singles Matches: A match in which one player plays against another.
1. **TEES:** The Boys 15-18 division will play from the **BLUE LJT** tee markers. The Boys 14 & Under division will play from the **WHITE LJT** tee markers. The Girls 12-18 division will play from the **RED LJT** tee markers.
 2. **AUTOMOTIVE TRANSPORTATION:** Players and caddies must walk at all times during play of any hole, and must not use or accept automotive transportation unless acting under the direction of an LJT Referee. Push/Pull carts are permitted.
 3. **RESULTS OF MATCHES:** The winning side of each match is responsible for reporting the results to a member of the Rules Committee.
 4. **ADVICE:** Partners from the same side may exchange advice.

SUPPLEMENTAL RULES OF PLAY

1. **OUT OF BOUNDS:** In addition to the items listed on the 2021 LJT hard card, out of bounds is defined by the following ways throughout the golf course
 - a. Inside edge (golf course side) of parking lot to the left and behind #9 and to the left of #10;
 - b. Inside edge of tennis-court fencing to the right of #2 & #9
 - c. The maintenance fencing left of #9

Note: A ball coming to rest on or beyond a road is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.
2. **TEMPORARY IMMOVABLE OBSTRUCTIONS:** Tents, signage and other temporary structures installed for this championship are deemed to be temporary immovable obstructions. The model local rule F-23 is in effect.
3. **IMMOVABLE OBSTRUCTIONS:** The following areas are deemed to be an immovable obstruction from which relief without penalty is available under Rule 16.1.
 - a. Maintenance equipment right of #16 fairway
4. **PRACTICE AREAS:** The practice areas (left of #1, #10 and right of #16) are deemed to be in the general area. The practice putting greens are deemed to be a wrong green, from which relief is MANDATORY under Rule 13.1f. The bunkers in the practice areas are deemed to be ground under repair in the general area. The range itself is in the general area and not part of the practice area.
5. **ABNORMAL COURSE CONDITION:** The following areas are deemed to be Abnormal Course Conditions from which relief is available under Rule 16.1.
 - a. Tree stumps that have been marked for removal and holes from previously removed tree stumps.
 - b. The path between #8 and #9 that has been dug up.
 - c. The turf nursery left of #13 Green is Ground Under Repair.
 - d. The croquet turf to the right of #9 fairway.
6. **PACE OF PLAY:** The established Pace of Play for Willow Brook Country Club is 4 hours and 15 minutes for 18 holes. The time to complete each hole is printed on the scorecard and the LJT Pace of Play Guidelines are listed on the reverse side of the scorecard.
