# POLICIES & PROCEDURES/TERMS OF COMPETITION

The Texas Golf Association Tournament Information & Guidelines, Policies & Procedures, including the Code of Conduct and Dress Code are in effect throughout the championship. Violations will be dealt with based on the severity of the misconduct. All competitors should be familiar with all Texas Golf Association Policies & Procedures, as well as the Terms of Competition. #### **RULES OF GOLF**

The South Mid-Amateur will be conducted using the 2019 Rules of Golf as approved by the United States Golf Association and R&A, its interpretations, and clarifications, 2022 Texas Golf Association Local Rules and Terms of Competition ("Hard Card") and all local rules provided by the Texas Golf Association.

#### WITHDRAWAL/NO SHOW POLICY

If you find you cannot compete in the championship, you must officially withdraw from the event by contacting Read Langhenry, Tournament Director at (214) 468-8942 ext. 304 or <a href="mailto:rlanghenry@txga.org">rlanghenry@txga.org</a>. #### FORMAT AND FIELD SIZE

Play will be contested over 54-holes of individual stroke play with no cut. The field is limited to 84 players. In addition to the overall champion, we will recognize the low Mid-Master finisher (Mid-Master is any player 40 years of age or older).

#### PLAYER CHECK-IN & COVID-19 SELF ASSESSMENT

There will be no official registration for the championship. Players should arrive to their starting time approximately 8-10 minutes prior to their starting time.

All competitors will be required to complete a COVID-19 Self-Assessment on their starting tee prior to their first round. Any player that has experienced symptoms or has been exposed to COVID-19 will not be allowed to participate and will receive a full refund (if applicable). Please stay at home if you have had contact with a suspected or known COVID-19 patient or if you do not feel well while displaying known COVID-19 symptoms.

# PRACTICE ROUND INFORMATION


There is no official practice round. Each player is allowed one (1) practice round at the negotiated rate of \$35 plus tax, including cart. Please contact the Forest Creek Golf Club golf shop directly to schedule a practice round at (512) 388-2874.

#### **STARTING TIMES/PAIRINGS**

Starting times/pairings for the first and second round will be made available no later than Wednesday, March 16<sup>th</sup> online at <a href="https://www.txga.org">www.txga.org</a>. Final round starting times/pairings will be available in the evening preceding play (approximately one hour after the completion of play) online at <a href="https://www.txga.org">www.txga.org</a>. Final round starting times will be re-drawn based on total score following the previous rounds of play.











#### **CARTS/TRANSPORTATION**

Cart fees for all championship rounds are included in the entry fee. Players are encouraged to utilize the provided motorized transportation. Carts will be limited to two (2) carts per group/pairing and a maximum of two (2) riders at a time. While a caddie is not prohibited from riding in the cart, the TGA has adopted a 'one-seat' policy as explained below.

#### **CADDIES**

Caddies are permitted during the Championship. Players are responsible for supplying their own caddie. Caddies must abide by the host facility dress code. The TGA will be utilizing the 'One-Seat' Policy throughout the championship. The player can ride in or move a golf cart with another player's caddie in it, so long as the player whose caddie is in the cart is not riding in another cart at the same time. As a reminder, players are responsible for the actions of their caddie.

#### **SPECTATORS**

Spectators are permitted and welcome to attend the Championship at no charge. Spectators are asked to park in the same lot as players. Spectators must observe host club policies while attending the championship and practice appropriate golf etiquette.

Spectator carts will not be permitted; those with documented ADA requirements may request use of a medical cart prior to the South Mid-Amateur. For more information, see below.

#### TGA MEDICAL CART REQUEST POLICY

Spectator carts are prohibited. However, spectators in accordance with ADA compliance may request golf carts. Requests for golf carts must be supported by complete documentation, including the fully completed <a href="Cart Request Form">Cart Request Form</a> and the required accompanying medical documentation specified in that form for all first-time requests. Any medical cart request that is granted by the TGA will be good for that individual for the remainder of that calendar season. A request will not be deemed complete until all required information and documentation has been provided. #### **CLUBHOUSE ACCESS AND PRACTICE FACILITIES**

### ADMITTANCE/PARKING

Competitors arriving at Forest Creek Golf Club should utilize the main parking lot.

#### **GOLF SHOP/CLUBHOUSE ACCESS**

The Clubhouse and Golf Shop will be open to players, spectators, and caddies during the duration of the South Mid-Amateur.

#### **PRACTICE FACILITIES**

Facilities will open to players one (1) hour before the first tee time. The range will not be available after completion of competition rounds.


#### **FOOD & BEVERAGE**

#### **BOTTLED WATER**

#### **AWARDS CEREMONY & PRIZES**

The South Mid-Amateur medallions will be presented to the champion (Overall & Mid-Master) at the conclusion of play on Sunday, March 20<sup>th</sup>. Golf Shop Credit redeemable only in the Forest Creek Golf Club golf shop will be awarded to the top finishers. A breakdown of Merchandise and Player of the Year Points will be available to view in the TGA Scoring Area.

#### PLAYER OF THE YEAR POINTS

Regional Player of the Year points will be awarded to the top 30 players, including ties.

#### **SCORE POSTING TO WHS**

The TGA will post all tournament scores to WHS (World Handicap System) after each round of play. These scores will be posted as competition 'C' scores. DO NOT post your own scores as this will result in duplicate postings.





OUT OF POSITION A group is *out of position* when it (A) completes play on a hole (replaces the flagstick or removes the last ball from the hole) later than the time scheduled in the attached chart <u>and</u> (B) reaches a par 3 hole and the preceding group has left the next tee *or* fails to clear the tee of the par 4 hole before the preceding group has left the putting green, *or* arrives at the tee of a par 5 hole when the preceding group is on the putting green. Both (A) and (B) must occur for a group to be out of position.

**TIMING** When the Committee determines that a group (or individual) will be timed, all players (or a specified individual) in the group will be notified by a Referee. Players will have 40 seconds to play a stroke. The timing of a player's stroke will begin when it is his turn to play and he can play without interference or distraction. Any time spent determining yardages will count as time taken for the next stroke.

On the putting green, timing will begin after the player has been allowed reasonable time to mark, lift, clean and replace his ball, repair his ball mark and other ball marks on his line of putt, and remove loose impediments on his line of putt.

FIRST OFFENSE – Informed of "Bad Time"

**SECOND OFFENSE** – One Stroke Penalty

EXCEEDING 40 SECONDS

**THIRD OFFENSE** – Two Stroke Penalty

**FOURTH OFFENSE** – Disqualification

**RULES / OTHER** 

**INCIDENTS** Should a ruling or other legitimate delay cause a group to lose its position, the group is obligated to regain its position within a reasonable time.

# **EVACUATION PLAN**

# **DISCONTINUANCE OF PLAY**

A SUSPENSION FOR A DANGEROUS SITUATION WILL BE SIGNALED BY ONE PROLONGED AIR HORN NOTE. All other types of suspension will be signaled by three consecutive air horn notes. Resumption of play will be signaled by two short air horn notes.

# **PRACTICE AREAS**

All practice areas are closed during a suspension for a dangerous situation until TGA Staff has declared them open.

# **EVACUATION PROCEDURE**

If the course is to be evacuated for a DANGEROUS SITUATION, groups must discontinue play immediately and evacuate the golf course. Players are asked to proceed directly to the Main Dining Grill for further information.





# **Local Rules and Terms of the Competition**

# FOR 2022 TGA CHAMPIONSHIPS

\*

The Rules of Golf as approved by the United States Golf Association and R&A Rules Limited govern play. The following Local Rules and Terms of the Competition are in effect at all TGA Championships and qualifying rounds. See applicable "Notice to Players" and Tournament Information for modifications or additions to these Local Rules and Terms of Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 1, 2019.

#### Unless otherwise noted, the penalty for breach of a Local Rule is the General Penalty: Match Play – Loss of Hole; Stroke Play – Two Strokes

**Out of Bounds** – Defined by the line between the course-side points, at ground level, of white stakes and fence posts. A ball that crosses any road defined as out of bounds and comes to rest beyond that road is out of bounds, even though it may lie on another part of the course.

**Penalty Areas** – When a penalty area is defined only on one side, it extends to infinity. When a penalty area is connected to the out-of-bounds edge, the penalty area extends to and coincides with out of bounds.

**Back-On-the-Line-Relief** – Model Local Rule E-12 as prescribed in the Clarifications to the 2019 Rules of Golf is in effect. This applies in the application of Rules 16.1c(2), 17.1d(2), 19.2b, and 19.3b.

# Abnormal Course Conditions (Including Immovable Obstructions) – See Rule 16.1.

- a. Ground Under Repair:
  - i. Areas completely encircled with white lines.
  - ii. French drains.
  - Bunker liners. Interference does not exist if the liner interferes with only the player's stance.
  - v. Seams of cut turf Model Local Rule F-7 is in effect.
  - Damage made by animals (hog, skunk, and the like) Model Local Rule F-10 is in effect.
- b. Immovable obstructions
  - White-lined areas tying into an obstruction are treated as part of the obstruction.
  - When landscaped or garden areas (flower beds, shrubbery or the like) are completely encircled by an obstruction, the obstruction and the landscaped area are treated as one abnormal course condition.
  - iii. Stakes, ropes, wires, or other objects supporting trees or tree limbs, provided they are not closely attached. The tree or tree limb is not part of the obstruction.
  - iv. Where the outside edge (non-golf course side) of a road or path defines out of bounds, the road or path is an obstruction.

Immovable Obstructions Close to Putting Greens – Model Local Rule F-5 is in effect and is modified as follows: For a ball in the general area, relief is allowed only when both the ball and the immovable obstruction lie in an area cut to fairway height or less, the immovable obstruction may be on the putting green.

Wood Chips and Mulch - Are loose impediments.

# Integral Objects -

- a. Cables, rods, wires, and wrappings that are closely attached to trees.
- b. Artificial walls and/or pilings when located within penalty areas.
- c. Where artificial retaining walls and/or pilings define the edge of bunkers, the artificial retaining walls or pilings are integral objects and are in the general area.

**Permanent Elevated Power Lines** – If it is known or virtually certain that a player's ball hit a permanent elevated power line or cable during the play of a hole, the stroke does not count. The player must play a ball without penalty from where the previous stroke was made in accordance with Rule 14.6.

Pace of Play – Rule 5.6b (3). The Texas Golf Association Pace of Play Policy is in effect

**Temporary Immovable Obstructions** (*TIOs*) – Tents, signage, electronic scoreboards, circulation fans and any other temporary structures installed specifically for this championship are deemed to be Temporary Immovable Obstructions. Model Local Rule F-23.

#### Specifications of Clubs and the Ball.

- a. List of Conforming Driver Heads Model Local Rule G-1 is in effect.
- b. List of Conforming Golf Balls Model Local Rule G-3 is in effect.
- Replacing Club that is Broken or Significantly Damaged Model Local Rule G-9 as prescribed in the Clarifications to the 2019 Rules of Golf is in effect.

Limiting When Stroke Made from Putting Green Must Be Replayed Under Exception 2 to Rule 11.1b – Model Local Rule D-7 as prescribed in the Clarifications to the 2019 Rules of Golf is in effect.

Methods for Stopping & Resuming Play – Model Local Rule J-1 is in effect.

- a. An immediate suspension of play will be signaled by one prolonged airhorn
- b. All other types of suspension will be signaled by three consecutive airhorn
- c. Resumption of play will be signaled by two short airhorn notes. All practice areas are closed during an immediate suspension for a dangerous situation until the Committee has declared them open. Players who practice on closed practice areas will be asked to stop practicing; failure to stop practicing might result in disqualification.

**Practice** – Prior to and after a round in stroke play, a player may practice on the designated practice areas. Rule 5.2b covering practice in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2.

**Scorecard Returned** – Scorecards must be attested and returned immediately after the completion of a round to the designated TGA scoring area. The player's score is considered final when the player has left the designated scoring area.

When Competition is Final – The competition is final when the trophy has been presented to the winner or, in absence of a prize ceremony, when all scores have been approved by the Committee. The result of a match is final when the Committee has approved the result as posted on the public scoreboard or website.

#### TGA Code of Conduct:

Players (and their caddies) are to observe proper golf etiquette at all times. Any abuse or disrespect of fellow competitors, officials, spectators, employees of the host facility, or other persons conducting or attending a TGA sponsored event can be grounds for disqualification from the event, and possible rejection of entry for future TGA events. Such abuse may be verbal or physical or threat thereof and includes but is not limited to: use of obscene language, physical damage to property or equipment including that of the TGA or the host facility, and being under the influence of alcohol or controlled substances during a round.
